Title of Document

Guildford borough proposed submission Local Plan: strategy and sites.

Subject matter and area covered

Guildford Borough Council has prepared the Guildford borough proposed submission Local Plan: strategy and sites for submission to the Secretary of State for Communities and Local Government. The Local Plan sets out the broad spatial planning and policy framework for Guildford borough up to 2033. The Local Plan includes our vision and ambitions for the future of Guildford borough with strategic objectives, policies and site allocations to meet the growth targets. It identifies the level of development over the plan period together with the locations where development should go.

Period of publication for representations

Representations are invited on the Guildford borough proposed submission Local Plan: strategy and sites for a period of six weeks, ending at 12 noon Monday 18th July 2016. This statement provides details on how to make comments.

Until 12 noon Monday 18th July 2016, all of the submission documents will also be available for inspection, during normal opening hours (excluding Bank Holidays) at Guildford library, Ash library and Horsley library.
